## ECB Annual Report 2022

Honourable President of the European Parliament, dear Ms Metsola,

*Dear Roberta,*

I am pleased to inform you that the ECB will publish its Annual Report 2022 in 23 official EU languages on the ECB's website at 11:00 CET on Thursday, 25 May 2023. Attached to this letter you find the electronic advance English version of the report, which we make available to you and the Chair of the Committee on Economic and Monetary Affairs of the European Parliament under embargo.

The ECB's Annual Report is prepared in accordance with Article 284 of the Treaty on the Functioning of the European Union and Article 15 of the Statute of the European System of Central Banks and of the European Central Bank. It will also be submitted to the Council of the European Union, the Eurogroup, the European Commission and the European Council.

The report covers the ECB's monetary policy and economic and financial developments in 2022 and presents the activities of the Eurosystem in its various areas of competence during the year under review.

Alongside the ECB Annual Report 2022, we will also publish the ECB's response to the points made by the Parliament in the resolution on the ECB's Annual Report for 2021, adopted in February 2023.<sup>1</sup> The
